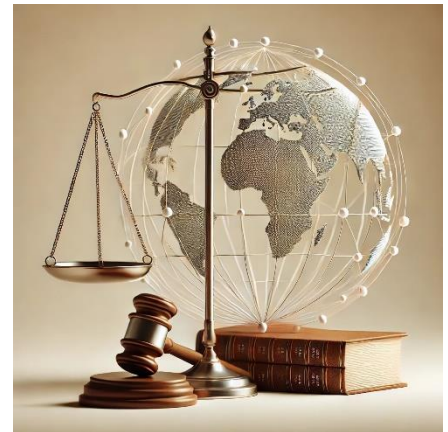

### **1. Civil Law Panel**

This panel will focus on legal developments and challenges related to civil relationships, private law, and the protection of the rights of individuals and legal entities. Suggested topics include, but are not limited to:

- ◆ **Fundamental rights and freedoms in civil and commercial relations**
- ◆ **Property law and challenges in its protection in an international context**
- ◆ **Consumer protection and global market challenges**
- ◆ **Digital contracts, electronic transactions, and the impact of technology on civil law**
- ◆ **Arbitration and alternative dispute resolution**
- ◆ **Family law and contemporary aspects of child and family protection**
- ◆ **Data protection and legal privacy challenges**

### **2. Criminal Law Panel**

This panel will address contemporary challenges in the field of criminal law and the justice system, particularly in relation to national and international security. Suggested topics include, but are not limited to:

- ◆ **Organized crime and criminal justice challenges**
- ◆ **Financial crimes, money laundering, and legal mechanisms for their prevention**
- ◆ **Cybercrime, digital security, and criminal liability in the virtual world**
- ◆ **Terrorism and violent extremism: Legal measures and their effectiveness**
- ◆ **Criminal justice reform challenges and their impact on human rights**
- ◆ **Juvenile justice**
- ◆ **Victims' rights in criminal proceedings and access to justice**
- ◆ **Corporate criminal liability and challenges in prosecuting legal entities**

### **3. Public Law Panel**

This panel will focus on the interaction between the state, institutions, and individuals in the context of public law, security, and human rights. Suggested topics include, but are not limited to:

- ◆ **Constitutional law and the protection of fundamental freedoms**
- ◆ **National security and balancing it with fundamental human rights**
- ◆ **Administrative law and transparency in decision-making**
- ◆ **Human rights in times of crisis and emergencies**
- ◆ **Legal challenges of European integration and its impact on the Albanian legal system**
- ◆ **Freedom of expression and its limits in the information age**
- ◆ **International public law and mechanisms for human rights protection**

Authors are encouraged to submit papers related to the general theme of the conference, focusing on **current issues, case studies, legal developments, and proposals for improving regulatory frameworks** in the relevant fields.

### **Paper Submission Guidelines:**

Authors must prepare their **scientific papers in both Albanian and English**, following the **guidelines** below:

- **Title:** Times New Roman, 14, Bold
- **Author:** Name, academic titles, institution, and email
- **Abstract:** In both Albanian and English, **250-300 words**, in **Italic "Times New Roman 12"**, single-spaced, justified text
- **Main Body of the Paper:** Should be divided into **relevant subsections**
- **Length:** **10 – 12 pages**, Word format
- **Text Formatting:** **Times New Roman 12, single-spaced**, justified text
- **References and Citations:**
  - **Footnotes:** Times New Roman 10, including title of the work, author, publisher, date and place of publication, and page number
  - For online sources: The access date must be included
  - Footnotes should be justified and end with a period

Failure to comply with the above guidelines may result in paper rejection from the conference and its publication.

Papers will be reviewed by an International Scientific Committee, and accepted papers will be published in a dedicated conference volume with an ISBN.
